- *Pro Contestants must provide four (4) items and the Rookie, Ringman & Junior Contestants must provide two (2) items for auction valued between \$25-? each. Each person will sell their own items. Three of the items will be sold on Friday night in the Pro Competition and the additional item & a mystery item will be sold during the Pro Finals Competition on Saturday. The Rookie, Ringman & Junior Contestants will sell both items on Friday night.*
  - *All Contestants must attend the Roll Call and Orientation Meeting scheduled for Friday at 4:00 p.m. A drawing will be held during the Orientation to determine the order of contestants in each contest group.*
    - *The exact judging score sheets will be provided at this meeting also.*
- There will be three (3) judges selected prior to the contest and all decisions made by the judges will be final.*
- *Pro and Rookie contestants shall be 18 years of age or older, current, active (paid) members of the AAA at the time of the entry deadline and must be registered for the AAA Convention.*
  - *Ringman contestants shall be 18 years of age or older, but are not required to be a current member of the AAA.*
    - *Contestants must pre-register and submit entry form prior to the contestants meeting at 4:00 p.m. on Friday to be eligible to participate.*
    - *Contestants who have had a license in the state of Arkansas for less than two years will automatically compete in the Rookie Division. There will be no run-off elimination. Rookie competitors may not compete in the Pro or Junior division.*
